Memorandum of Understanding (MOU) between

School of Electronics & Computer Engineering Jeonnam National University Republic of Korea

and

Computer Science Department Stony Brook University USA

Jeonnam National University and Stony Brook University have established an agreement for this Memorandum of Understanding (MOU) for cooperation in education and research.

- 1. Both parties will encourage the following activities to promote international academic cooperation:
 - Exchange of materials in education and research, publications, and academic information
 - ii. Exchange of faculty and research scholars
 - iii. Exchange of students
 - iv. Joint research and meetings for education and research
 - v Technical assistance
 - vi. Global Research Laboratory (GRL) program under National Research Foundation (NRF)
- This Memorandum of Understanding (MOU) forms the framework for cooperation between the
 parties to identify and achieve shared goals and objectives, and to facilitate and develop a genuine
 and mutually beneficial exchange process and research relationship.
- 3. This Memorandum of Understanding shall remain in effect for five years, unless (i) either party terminates sooner by notifying the other party in writing, or (ii) the joint activities contemplated by this Memorandum of Understanding are completed before the end of the five-year period. The parties may extend this Memorandum of Understanding (MOU) beyond five years by mutual written agreement.
- 4. Stony Brook University may use the name of Jeonnam National University, or any member of Jeonnam National University's program staff, in any publicity, advertising, or news release without the prior written approval of an authorized representative of Jeonnam National University. Jeonnam National University may use the name of Stony Brook University, or any employee of Stony Brook University, in any publicity, advertising, or news release without the prior written approval of Stony Brook University.
- 5. Each party shall designate a person or office to serve as liaison for implementing this Memorandum of Understanding. For Jeonnam National University, the contact person will be Prof. Jinsul Kim
